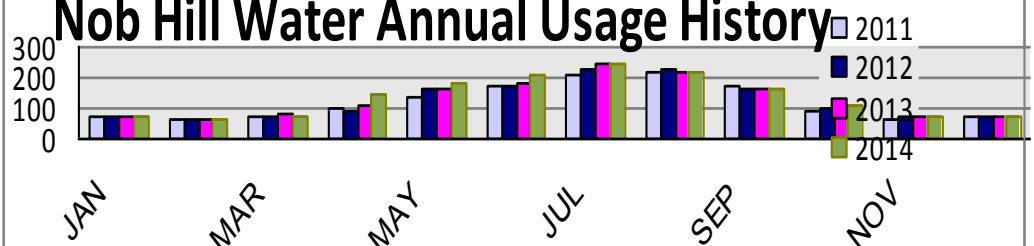
~ New Mainline Replacement ~
